The Eastern Interconnection States' Planning Council has released its web-based Energy Zone Mapping Tool to identify areas within the Eastern Interconnection conducive to clean energy resource development. Specifically, the EZ Mapping Tool supports twenty nine (29) clean power generation and storage technologies technologies capable of grid-level power production. There

are over two hundred and sixty (260) data layers in the mapping library that can be processed using various user specified screening factors and criteria to identify areas most suitable for clean energy resource development. This session will not only show you how to use the tool but talk about practical applications and the benefits to a region. There will be a demonstration on a big screen as well as the opportunity to test-drive the program on individual computers.
